### **Statement of Purpose:**

The success of Academy of Accelerated Learning, (AAL) is based on the district’s mission and vision to emphasize academic excellence while promoting student achievement. The strong performance is reinforced through our academic framework model of *Rising Standards with High Expectations* to:

- **Accelerate**, innovate academic programs infused with Science, Technology, Engineering, Arts and Mathematics (STEAM);
- **Actively engage** students in learning relevant skills, concepts and design process which reinforces language, math and science skills; and,
- **Learn and lead** with a strong culture of meaningful personal relationships of students, teachers, parents and family.

To this end, we want to establish partnership with parents, school and with the community. Parents play an extremely important role as the children’s first teachers. Their support for their children and for the school is critical to their children’s success at every step of the way.

In support of strengthening student academic achievement, Academy of Accelerated Learning receives Title I, Part A funds and develops jointly with, agree on with, and distribute to, parents of participating children a written Parent and Family Engagement policy that contains information required by section 1118(a)(2) of the Elementary and Secondary Education Act (ESEA) (campus wide Parent and Family Engagement policy). An organized Parent Advisory Committee (PAC) is established to create a forum for parental input and involvement. Our school publicizes in English and Spanish, disseminates to teachers and other staff, parents, students, and the community, the results of the annual review.

### **C. The school will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional Parent and Family Engagement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend.**

**Actions:** Related information regarding parent programs, meetings, and other activities will be sent to parents in a timely manner. This information can be distributed through weekly newsletters, phone calls, web sites, or through classroom teachers. Our school provides specific training and materials to help parents work with their children to improve achievement. An annual meeting where parents will learn about the requirements of the school's Title I program will be held. A letter will be sent to each child's parents and meeting will be announced on the website. Parent meeting conferences will be held twice a year, fall and spring. Meeting times needs to be accommodated to the needs of the parents. Communications with the parents will be in a format and a language that they can understand.

### **D. The school provide parents of participating children timely information about programs under this part; descriptions and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress and the proficiency levels students are expected to meet; and if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any suggestions as soon as practically possible.**

**Actions:** Our school communicates with parents often the state's curricular and assessment expectations based on literacy and numeracy, school wide requirements in relation to the delivery of instruction, data analysis to evaluate student work, individual classroom procedures for academic success of our students. AAL uses a variety of communicative techniques such as our School Handbook/Compact, Monthly Calendar and Newsletters, School Website, Teachers Letters to Parents, PIKmyKids (phone call system), Parent/Teacher Conferences, Home Visits, PAC Meetings, Family Fun Nights, Cultural Events, Surveys, Use of technology during parent workshops, Open House, Classroom and Fieldtrip Volunteers, Grade Level School Night, Report Cards, benchmark results. The school provide childcare during meetings. Parents attend professional parent conferences. The multitude of activities are used to solicit parent input, participation, for delivery of important information and productive relationship between home and school concerning student achievement.
